Ordinance # 6-2013 – FY 2013-2014 Budget


Council Member Cox made a motion to have a Public Hearing to discuss the FY 2013-2014 Budget. Council Member Sally seconded the motion. All in favor none opposed. Motion carried. Johnny Cribb, City Administrator and Courtney Soler, Finance Director presented a Budget presentation explaining the changes requested at the Council Workshop on May 21, 2013. The City will have less employees this FY. Revenues, Sewer Bond pay off, Restroom/Concession facility, and 911 Capital Sheets were explained. The City is looking into going with the State Health Plan for our Health Care options. With this plan the City of Hanahan would be required to pay a portion of the family/dependent coverage. A wage study with salary caps will be done before January 1, 2014. All Council Members were happy with the proposed budget. Council Member Owens made a motion to close the Public Hearing. Council Member Sally seconded the motion. All in favor none opposed. Motion carried.

Council Member Sally made a motion to approve the Introduction and First Reading of Ordinance # 6-2013 FY 2013-2014 Budget ~~presented with the Council salary raise removed. If the City goes with the State Health Care Plan, Council would receive the same Health benefits as any other employee,~~ as written without the Council salary raise. Council Member Owens seconded the motion. All in favor none opposed. Motion carried.


**ADJOURNMENT**
